The Chairman welcomed everyone to the meeting and gave a summary based on his letter that been previously circulated to members.

#### Minutes of the last Annual General Meeting held on 14<sup>th</sup> July 2016:

The minutes of the last AGM were accepted unanimously by the meeting, having been proposed by Steve Wallace and seconded by Des McGovern. These were signed by the Chairman.

#### Matters arising:

There were no actions from the prior meeting.

#### Chairman's Report:

The Chairman thanked the members for their support of the club. We are a member-run club and would not exist otherwise. He thanked all the committee members for their help during the past year. In particular, he recognised the efforts of those that were standing down (Ian Wild and Phil Warlow) and of the stalwarts who keep the tables cleaned on a regular basis.

It has been a year in which we have undertaken some remedial work to heating and water systems, and in which a web site has been created.

#### Treasurer's Report and Annual Accounts:

The club is grateful to Richard Arnold for stepping into the role of accountant. Dom presented the accounts, which had been reviewed and signed by Richard Arnold. In the year to 31 May 2017 the club recorded a profit of £1977, an increase on last year's figure of £470. We now have a balance of over £22,000 and will be attempting to reduce this with expenditure on a new glass cleaning machine, replacement cooling in the cellar, and improved furniture and floor covering.

Acceptance of the accounts as stated was accepted unanimously by the meeting.

### Election of Officers:

There being no other nominations, the following Members were proposed as Officers by Steve Sears, seconded by Tim Wilson, and accepted unanimously by the meeting:

### Election of Committee Members:

These were proposed by Darren Cabbage and seconded by Chris Satchwill. They were then accepted unanimously by the meeting.

### Any Other Business:

The web site was welcomed but seems to be already somewhat out of date. The Chairman explained that there was a technical issue at present but when that was resolved then it would be more frequently updated. In particular, it is proposed to upload minutes, competition results, news (e.g. events) and beers on offer.

In regard to beer, there was a feeling amongst some that there could be more of the old favourites on offer. It was explained that opinions differ in the club as to which type of beer is preferable, with some preferring a lighter style, and some the stronger, darker beers. We will endeavour to have both options when we return to having two beers on offer, but this cannot be guaranteed.

It was also noted that our healthy bank balance will allow a continuation of the renewal of cloth, probably on a rolling 3-year basis.
