Danny was warmly welcomed to his first committee meeting.

## 1. Previous Minutes ( $\mathbf{1 4}$ Sept. 2021)

No corrections had been received by the secretary and the meeting approved these unanimously. Actions updates are included in their appropriate sections.

## 2. Financial Update

The AGM was held (finally) in November and the audited accounts for the financial years ending May 2020 and May 2021 were passed unanimously.
Dom reviewed the half-year figures. We are presently down about $£ 4000$. Some of this was due to waiving renewal fees, and some to declining bar margins, which in turn was partly due to price increases and partly due to wastage. We also have an extra cost (POS infrastructure). It was agreed to wait for full-year figures before deciding whether any pricing actions are required.
Crisps and chocolate are now 75 p, as these were previously loss-making.

## 3. Facilities

Light meters. One of the new meters (nearest to the bar) has been misbehaving. Coins are getting stuck before reaching the container. Dom knows how to "fix" the runner. However, we are having repeated issues. It will still be under warranty. Steve W. will speak to the supplier (SP Wales) to see what they advise next. Dom can take pictures of the inside of the box if required.

Television Upgrade? Our present TV is HD, but we would need to upgrade to HD Freeview. Boxes for this start at $£ 35$. The more expensive option will cost us about $£ 170$ (revised figure from Dustin). We agreed to buy the better box at the higher price and Dustin will source this for us.

Darren noticed water accumulating in the cellar. Since cleaning it thoroughly, however, there has been no sign of any further leakage.
Contract Cleaning. There does not seem to be much difference in the club after it has been cleaned. We wonder whether it is really being done thoroughly. We have never given them a specification, so Steve W will ask them to specify exactly what they are doing.

Security of Club. A member reported finding their cue case opened and the cue in parts scattered about the club. It may be worth reminding members that only the cues along the left-hand wall are for general use. An email reminder will be sent.

Electrical Problem. The fuse box RCD sometimes trips because of a current leak. It happens when the heating comes on, but this does not necessarily mean a faulty boiler. Bruce Glasby has done PAT testing and other investigations and cannot find a problem. Nor could we reproduce the issue for Henley Heating \& Plumbing. The next step is to ask Bruce to put the heating on a separate circuit.
